## Man and Woman of the Year

The Man and Woman of the Year is an annual event, meant to recognize individuals who have contributed to our clubs, our local ski councils, and skiing in general. It's a multi-stage process:

1. Our club members can nominate whoever they wish, by March 13. **Send your nominations to any member of the Board** (see all the contact names listed at the tail end of each copy of "Lift Lines", or see the "Contacts" page on our web site: **www.mthigh.org/Contacts.htm**)

2. At one of the upcoming monthly Board meetings we'll select one man and one woman among all the nominees. These will be our club's man and woman of the year. There is no formal award. The nomination is a public recognition, and a reward in itself.

3. Next, the man and woman of the year from each our local clubs will be referred to the **Northwest Ski Club Council** (which represents about 30 clubs in the Northwest). The Council will then select just one pair to be the Council's man and woman of the year.

4. Next, the two individuals selected to be the NWSCC's man and woman of the year will be referred to the **Far West Ski Association** (representing several ski club councils from Oregon, Washington, California, Nevada, Arizona, and New Mexico). California has several Councils, so there is a grand total of about 7 or 8 Councils, and thus about 7 or 8 pairs of nominees. These final nominees are asked to come to the Far West Convention, usually held in May. During the convention, they will be interviewed by a panel of "judges" (volunteers from various Councils), and a final pair will then be selected as the Man and Woman of the Year for the whole Far West region.

Our club's selection process is quite informal. At the NW Council level, there is a more formalized process. A committee is usually appointed to review the clubs' nominees. Sometimes there is a written questionnaire. Other times they are asked to say a few words about themselves at the Council meeting.

The Far West Ski Association has the most formalized procedure, consisting of formal interviews by a whole panel of judges.

Two years ago, in 2004, **Emilio Trampuz** became the Far West Man of the Year. **Marge Fons**, from Arizona, was the Woman of the Year.

Last year, 2005, **Debbi Kor** and **Steve Coxen** were nominated by our Council. Steve Coxen went on to becomethe Far West Man of the Year. The Woman of the Year was **Barbara Bryant** (Sierra Council).

The only other winner from the Northwest was **Diane Hicks** (a Skiyente ski club member), who became Woman of the Year in 1999.

There are no prizes at the club level, other than the formal recognition.

Those who get nominated by the Councils, i.e. those 7 or 8 pairs of finalists, are rewarded with a 2-day vacation at Big White.

The two final winners, the Far West Man and Woman of the Year, are rewarded with a 5-day vacation for two at Big White/Silver Star, the sponsors of this competition.

Answer: Sorry, we went there last year. Our club is just not big enough to support repeated trips to the same place every year. People who went with us to Big Mountain last winter want to do something a bit different this year. So, for the sake of variety, we try to organize a different kind of trip every year. We are blessed to live within a day's driving distance of about 60 ski areas, and there are dozens more within a couple of hours by plane. Big Mountain, Montana is a great place, and we'll probably go back there again in a few years.



All you have to do is show up at the **"Gemini**" trail, 9:30 am.


There will be another such clinic just be-




## Far West Championships (Kirkwood, CA)


## New Lift at Timberline Approved

Good news! **Timberline's** proposal to build the new chairlift and trails was accepted and it has now (as of January 23) made it through the appeal period with NO appeals. That means Timberline finally has the green light!

Timberline is now planning to clear the trails this summer.

This will be quite an improvement, and will give Oregon skiers the first totally new chairlift and associated set of new trails since Bachelor's expansion in the mid 80's. Very exciting.

The new express lift will be located between the existing Pucci and Stormin' Norman lifts. It's base will be almost as low as the bottom of Molly's Express, while the top station will be higher than the bottom of the Magic Mile Express.

#### Vision of Skiing in the 21st Century: Tree Thinning!

Safety

Building up on the idea of a new vision for skiing in the 21st century, started in the July/August 2005 issue of "Lift Lines", resorts could make the slopes **safer** by providing more opportunities for us to practice **controlled turning**, by simply setting up a variety of **fun obstacles** on the slopes. This would not only make the slopes more **fun**, but would also **slow traffic down**, make the slopes **safer**, and lift lines **shorter**.

Urge ski areas to implement this idea, in any of a number of ways. Here's just one of them:



#### Thin the forest in places!

This is the flip side of planting new trees, but the end result is the same: giving us some obstacles to play slalom in.

Thinning of the forest in places where it is now too thick to be skiable is an idea recently proposed by **Dave Riley**, Mt. Hood Meadows manager. See Dave's blog at <u>www.skihood.com</u>.

Thinning can be good for the forest, preventing forest fires, and making the forest healthier. It's also good for skiers.

## **Sno-Park Permits**

An interview with Beth Royce member of the Sno-park advisory committee and also a Mountain High club member

Many ski areas in Oregon require a snopark permit. You can get a ticket if you don't have one. A one-day permit costs \$3,

or you can pay \$15 for the whole season. Did you know that our very own Beth Royce is on an advisory comittee that helps the program function? She agreed to tell us more about it.

#### Q.: Who exactly is on the Sno-park comittee?

A: Officially, the committee is "Winter Recreation Advisory Committee". We advise ODOT on the Sno-Park fund. Note the word is "advisory". We have no real power but we are definitely listened to. The 7 voting members of the committee are required to be as follows: 2 persons from ski areas, 1 from Oregon Nordic Club, 1 from Pacific Northwest Ski Association (currently

myself), 1 from Oregon Snowmobile Assoc., and 2 from the general public. The WRAC advises ODOT on priorities for plowing Sno-Parks, establishing fees for the parking permits, and the level of enforcement of the permit requirement. The committee meets four times a year, generally in Salem. Members serve on a volunteer basis.

# Q: Is it true that Mt. Hood ski areas like the permits, because it frees them from the responsibility of plowing their own parking lots?

A: Not accurate. Mt. Hood ski areas plow their snoparks and get **reimbursed** from the state Sno-Park fund for doing the plowing. In general, the state is trying to get users to pay for whatever they use. In this case, those who play in the snow pay to have their parking area cleared. The plowing is done by the state (ODOT) or by private contractors (ski areas) who have an agreement with ODOT to participate in the Sno-Park program. Sno-Parks must be designated. There is an application process to be part of the Sno-Park system or to expand an existing park. A list of all the Sno-Parks is available at DMV offices and the brochure includes lots of info.

## Q: Are the ski areas on Mt. Hood the only ones requiring sno-park permits? What about others?

**A:** There are 3 ski areas which do NOT participate in the program: Mt. Bachelor, Hoodoo, and Willamette

Pass. Willamette Pass this year has new owners who decided to drop out of the program. Do not yet know why. These areas who do not participate do all their own plowing and get no Sno-Park funds to help pay for it. Originally, Mt. Bachelor was the only area who did not participate and I believe the reason was that they (as a "destination" resort) did not want their patrons to pay for a lift ticket and then also have to pay for a Sno-Park permit, especially since many of their clients would be here for multiple days and need the season permit.

Q: The multi-State agreement statement on the back of the sno-park permits about them being valid, by mutual agreement, in Idaho, Washington, and California, seems to apply mainly to cross-country skiers, snowshoers, or snowmobilers, who want to park at road-side parking lots. For alpine skiers, skiing at lift-served ski areas, it seems the above statement is meaningless, because none of the ski areas outside of Oregon require sno-park permits.

A: This may be true. I do not know if alpine areas in



other states require the permit. Each state program is organized a little differently. (I am usually on the bus!)

Q: How is the money collected from sno-park permits used? Does it all go toward snow-plowing? Isit used in other ways as well? How much of it goes to administrative costs? Any published reports?

A: The Sno-Park program is funded completely and only from the sale of the permits. If the fund runs out of money in a bad snow year there will be no clearing of snow in the parks. There is no other source of funding. The money in the fund can only be used for snow removal and enforcement. IF there is money remaining in the fund it MAY be used for maintenance and development of Sno-Parks or carried over for use in the following year. The committee feels that there is a minimum amount of money that we need to keep in the fund in order to plan for a heavy snow year. There has been no money allocated for maintenance or development for about 7 years. At the present time, we are greatly concerned about maintenance because many of the parks are in need and it will be increasingly more costly to plow them if they are not maintained. The committee has information about costs. rates, enforcement fees. We consider ourselves to be the "watch dogs" for the fund. No published reports.

Q: Would the lift-ticket prices really go up if the Mt. Hood ski areas had to pay for their own parking lot maintenance? Currently, there is only \$1 difference in the lift ticket prices beetween Mt Hood Meadows and Mt. Bachelor (which is not in the program).

A: Yes, it would seem reasonable for the lift ticket prices to go up because MHM would not receive any reimbursement from the Sno-Park fund. I cannot comment on how any ski area determines their prices.

Q: Do sno-park permits leave a negative impression on tourists? Generally, at ski areas, there are no visibly posted signs warning people about the need for snow-park permits. So, visitors to Mt. Hood are sometimes slapped with a parking ticket for not having a snow-park permit that they didn't even know existed. Imagine how we would feel if we drove up to a Lake Tahoe ski areas and got a parking ticket there (if they had a similar program).

A: As far as I know, there are signs at every Sno-Park. Other western states also have a permit system: WA, CA, ID. Users also must pay for summer usage (Forest Service Pass, Campground fees, etc.). This seems to be the trend (users pay). The committee realizes that we need to sell permits to sustain the program so we want it to be easy for outdoor winter recreationalists to do so. We have to work through DMV, however, and this is not a priority for them. We want DMV to have a booth at the ski show each year and last fall they said that they would do this. At the last minute they decided they did not have the staffing required. The permits are available at DMV offices, GI Joe's, ski shops, ski areas, convenience stores (in Sandy), etc.

## Q: How did you get involved with the program?

A: The NW Ski Club Council has always had a representative. We were designated by Pacific Northwest Ski Association to provide the alpine representative. I took over the job from **Rita Furnanz** in 1996. She had been our rep for about 8 years. The Sno-Park system started in 1977. **Pat Fuller** of Cascade Ski Club (who was also active in Pacific Northwest Ski Assoc.) was our first representative. Presently, I am the committee Chair. My term on the committee runs through 6/09 and my term as Chair through 12/07.

#### Q: What would happen if the sno-park permits were abolished, or if they were to apply only to undeveloped, road-side parking (and not apply to organized ski areas any more)?

A: The goal of the committee is to see that ALL Sno-Parks remain open for use at all times for all types of winter recreationalists. We feel that the smallest parks are just as important as the largest. About 8 years ago, the fund balance was \$0.00. We barely made it through that winter. We do not want that to happen again. The committee is adamant that we do not ever want to have to decide which parks get plowed and which do not because of a lack of money.

Your thoughts, comments, and other questions will be appreciated. Hope this information is helpful. The next committee meeting is at the Oregon Dept. of Transportation, 800 Airport Rd., Salem, April 19 at 10:00 am.
